# **Smart Commute Toronto Bike Month Contest - Official Contest Rules**

NO PURCHASE OR PARTICIPATION FEE NECESSARY.

## Agreement to Rules

By participating in the Smart Commute Toronto Bike Month Contest ("**Contest**"), you (the "**Entrant**") agree to be fully unconditionally bound by these Official Contest Rules (the "**Rules**"), and you represent and warrant that you meet the eligibility requirements set forth herein. In addition, you agree to accept the decision of the City of Toronto (the "**City**"), as final and binding as it relates to the content. The Contest is subject to all federal, provincial, and local laws.

## **Contest Description**

The City's Transportation Services Division is conducting a Smart Commute Toronto Bike Month Contest, herein known as "Contest". The Contest is to promote and incent cycling and logging trips on the Smart Commute Tool (either the <u>online</u> or mobile application) during Toronto Bike Month (June 1, 2025 to June 30, 2025). Entrants that log their cycling trips in the Smart Commute Tool will be entered to win one (1) of five (5) \$50.00 gift cards for Smart Commute Toronto Workplace members and one (1) of five (5) \$50.00 gift cards for community members that live in Toronto.

#### Contest Period

The Contest begins on Sunday, June 1, 2025 at 12:00 AM Eastern Time (ET) and ends on Monday June 30, 2025 at 11:59 PM ET (the "**Contest Period**"). Entrants will have up until 11:59 PM ET on July 7, 2025 to log their cycling trips taken during the Contest Period on the Smart Commute Tool.

## **Eligibility**

Must be 18 years or older at the date of entry to participate.

Must be an employee at a Smart Commute Workplace located in Toronto, or a community member that lives in Toronto.

Cannot have won any award or prize in any other Smart Commute Toronto contest in the 2024 calendar year.

Cannot be an employee of the City's Smart Commute team within Transportation Services Division's Traffic Event Management Planning Unit or an officer, director, or elected official of the City or its Agencies, Boards and Commissions.

Cannot be an employee, officer, or director at pointA.

Entrants are limited to individuals only; commercial enterprises and business entities are not eligible to enter.

#### **How to Enter**

The Contest requires eligible individual to submit a bicycle trip taken by the Entrant between June 1, 2025 to June 30, 2025 on the Smart Commute Tool (the "Entry"). Entries may be submitted to the Smart Commute Tool using connected apps such as Strava, Garmin, Fitbit, or Under Armour.

Entrant's receive one Entry per bicycle trip logged with a maximum of two Entries per day during the Contest Period. Bicycle trips can be taken on two separate days but then logged onto the Smart Commute Tool on the same day of the Contest (e.g. bicycle trip was taken on June 1 and June 2 but both trips were logged onto the Smart Commute Tool on June 2 would equal to two Entries). The total maximum amount of Entries per person during the contest period is 60 Entries.

Bicycle trips of any duration, distance, or destination can be logged as an Entry on the Smart Commute Tool in the Contest.

To submit an Entry the Entrant must have:

- a) A user account registered on the Smart Commute Tool. and linked to their Smart Commute Workplace located in Toronto, or
- b) A user account registered on the Smart Commute Tool as a community member that lives in the City of Toronto.

Each eligible bicycle trip must be logged into the Smart Commute Tool during the Contest Period to be considered an Entry

You will be required to provide the City with your full name, email address (either work email address if member of a Smart Commute Toronto Workplace or a personal email address if a community member that lives in Toronto), phone number and address (either work address if member of a Smart Commute Toronto Workplace or home address if a community member that lives in Toronto) to be eligible for the Contest.

The City will determine, in its sole discretion, what constitutes non-relevant and inappropriate content and may remove entries from the Contest without notice.

The City and its affiliates are not responsible for late, lost, misdirected, or delayed entries. Without limitation, the City and its affiliates will not be liable for the failure of any Entry to be received.

## **Entry Limits**

There is a limit of two (2) Entry per person per bicycle trip during the Contest Period. Multiple bicycle trips may be logged each day but only two bicycle trips a day that are logged onto the Smart Commute Tool will be considered as Contest Entries (see "How to Enter" for further details). All bicycle trips must have been taken between Sunday June 1, 2025 at 12:00 AM ET and Monday June 30, 2025 at 11:59 PM ET and be logged within the Smart Commute Tool by Monday July 7, 2025 at 11:59 PM ET. You may only enter the contest as an employee of a Smart Commute Toronto Workplace or as a member of the public, not both.

If it is discovered by the City (using any evidence or other information made available to or otherwise discovered by the City) that any person has attempted to: (i) exceed any of the limits provided in these Rules; and/or (ii) use multiple names, identities, email addresses, Accounts

and/or any automated, macro, script, robotic or other system(s) or program(s) to enter or otherwise participate in or to disrupt this Contest; then the Entrant may be disqualified from the Contest in the sole and absolute discretion of the City. Your Entry may be rejected if (in the sole and absolute discretion of the City) it is not submitted and received in accordance with these Rules during the Contest Period.

All entries and entrants are subject to verification at any time and for any reason. The City reserves the right, in its sole and absolute discretion, to require proof of identity and/or eligibility (in a form acceptable to the City – including, without limitation, government issued photo identification): (i) for the purposes of verifying an individual's eligibility to participate in this Contest; (ii) for the purposes of verifying the eligibility and/or legitimacy of any information submitted (or purportedly submitted) for the purposes of this Contest; and/or (iii) for any other reason the City deems necessary, in its sole and absolute discretion, for the purposes of administering this Contest in accordance with these Rules. Failure to provide such proof to the complete satisfaction of the City within the timeline specified by the City may result in disqualification in the sole and absolute discretion of the City. The sole determinant of the time for the purposes of this Contest will be the City's Website server machine(s).

### **Winner Selection**

A random draw will be used to determine the winner of the Contest. Each Entrant shall be eligible to win only once. There will be ten (10) prize draws. Winners will be selected after the Contest closes. Odds of winning the random draw depends on the number of eligible entries received.

The City will notify the winners exclusively by email. The City shall not be held liable for the winner's failure to receive the notice that they have won.

Failure of the winner to claim the prize within 30 calendar days from the time the award notification was sent, showing proper identification, completing a skills-based test (if applicable), and completing and executing a declaration and release as required may result in the forfeiture of the prize.

Winner's must claim their prize by appearing in person at the City of Toronto, Transportation Services Division (Union Station65 Front Street West, Toronto, ON M5J 1E6). If no response is received within the required time, the winner will be disqualified and another Entrant will be randomly selected.

Winners' names and photographs may be published in promotional materials directly related to the Contest and may be publicized in any other reasonable manner the City considers appropriate for the purposes of the Contest.

The City collects personal information for the Contest under the legal authority of *City of Toronto Act*, S.O. 2006, Chapter 11, Schedule A, s. 136 (c). The information will be used as described in the Rules and to contact you about your submission to the Contest. #### **Prizes**

There will be a total of ten prize winners. Winners will receive gift cards from either Canadian Tire, MEC, or PRESTO valued at \$50.00 to be rewarded as a prize. Winners will be selected from the following entry groups:

- Five (5) winners will be selected from Smart Commute Toronto Workplace entrants.
- Five (5) winners will be selected from community members that live in Toronto.

There are no early bird prizes. Limit of one (1) prize may be awarded per Entrant. All prizes must be accepted as awarded.

The specifics of the prize shall be solely determined by the City. The City reserves the right to substitute a prize or a prize component with one of equal or greater quality/value. No cash or other prize substitution permitted except at the City's discretion. The prize is non-transferable. Any and all prize related expenses, including without limitation any and all federal, provincial, and/or local taxes shall be the sole responsibility of the winner. No substitution of prize or transfer/assignment of prize to others or request for the cash equivalent by winners is permitted. Acceptance of a prize constitutes permission for the City of Toronto to use winner's name, likeness, and photo entry for purposes of advertising without further compensation, unless prohibited by law.

#### **Additional Details**

The decision of the City with respect to all aspects of this Contest are final and binding on the Entrant without right of appeal.

The City reserves the right, in its sole and absolute discretion and without prior notice, to cancel or modify the Contest in the event that, in its opinion, the holding of the Contest would be prevented for one reason or another, including a technical failure or breakdown, an unauthorized intervention, fraud or any other cause beyond the control of the City which would compromise the management, security, impartiality, integrity or smooth running of this Contest.

This Contest is null and void where prohibited by law. Any dispute regarding the organizing or conduct of this Contest may be submitted to the Director, Traffic Management, Transportation Services Division who may be contacted by dialing 311 on your phone.

The City is not responsible for late, lost, misdirected, or delayed entries. Without limitation, the City and its affiliates will not be liable for the failure of any entry to be received.

The City is not responsible for computer system, hardware, software or program malfunctions or other errors, failures, or delayed computer transactions or network connections that affect the Contest or your participation in it. Furthermore, the City is not responsible for: 1) lost, misdirected, misplaced, illegible, unintelligible, incomplete or late Entries or 2) any act, failure to act, or delay regarding the transmitting or processing of Entries. The City is also not responsible for any technical delays in submission emails, Entries and/or uploads and updates.

The City reserves the right to disqualify any Entrant the City has reason to believe does not comply with the Rules. If after the awarding of the Contest prizes a Contest winner is disqualified or determined to be ineligible, an alternate winner will be selected using the same process described above. Alternate winners are subject to all requirements set forth in these Rules.

The City reserves the right to change or alter these Rules in accordance with the *Accessibility* for Ontarians with Disabilities Act, 2005, S.O. 2005, c. 11 ("AODA").

The City is entitled to interpret these Rules as required, and its decisions are final.
